- a. Cross Country
 - Coaches asked if we needed to state how to break a tie – not needed as we can have a tie for League Champion
 - Coaches want JV awards based on third race – We will be recognizing the JV Team Champion with a team plaque – just like all of the other sports.
 - The state had changed the CBED enrollment standards and will no longer be setting parameters except the D5 is no larger than 500 and D4 is no larger than 1100.
 - Each section can change it, but CCS will not change it for this year and will look into it for next year.

- b. Volleyball
 - add to bylaw 1102 a (page 73) – who goes to CCS - top 3 in Foothill and League Champion from Skyline.

 - want to modify to keep start dates, but make as a date, not as 1st Monday, and to get rid of scrimmage and contest dates
